3. I agree to pay all monies (in US dollars) to Master Cleaners Inc. If the credit card becomes invalid for any reason, I agree to pay any finance charges, collection fees, and / or legal fees required to collect payment on my account.
4. Master Cleaners has blank garment listing forms available upon request to be included with each order to be processed. Should I choose to request and fill it out and a discrepancy is found, Master Cleaners will not process the order until I can be contacted.
5. I understand that return orders will not be left during inclement weather unless the delivery location is protected from the weather. Should weather prevent delivery, Master Cleaners Inc. will return my garments back to the Main Plant located at 519 W. Washington St. Suffolk, VA 23434 and any garments will be delivered back on my next scheduled delivery day. However, if I wish to pick them up before that time, I may do so during normal business hours.
6. I authorize Master Cleaners personnel to be on my property and/or at the specified delivery location solely for the purpose of picking up and delivering my cleaning.
7. To protect our customers' privacy, we do not disclose, sell, or give out our customers' information. I authorize Master Cleaners to contact me via text, telephone, and e-mail regarding their services and/or my use of their services.
